WEST VALLEY FAIR HISTORY

In the summer of 1951, Walter and June Gano sat on Bill Stobie's front lawn and discussed the need for a Community Fair. With the help of Dave Hull and Loren Rants the first Ahtanum Valley Fair, as it was called, was held.

The first fair was held in Ahtanum behind the Ahtanum Grange. Complete with cardboard ribbons, the local 4-H kids competed and gained the experience to help with future fairs. Events such as the parade and watermelon-eating contest began at this first fair. Since it was such a success, the fair was planned again for the following year...and the year after that..... The fair was truly a "community fair", with live entertainment and PTA type games for the kids.

In 1959 the Royalty contest started. And still the fair continued to grow. The two-day event expanded to 3 in 1961, to four-day the following year, and to five days in 1964 to accommodate a two-day horse show. A new barn was constructed in 1965 to hold all the livestock entries; this barn was moved in 1969 and is now the "steer barn" at our current location.

During the 1960's expansion, events such as the dog show were added. In 1969 the entire West Valley Fair was moved from Ahtanum, it's home since the fair inception in 1951, to the Tampico Saddle Club grounds in Wiley City, which is our present location. The fair in 1969 was a "no holds barred" event; an estimated 6,000 people attended the fair over the four-day event, some 2,000 on Saturday alone.

The fair continued strong throughout the '70's and early '80's. Construction was started on the "Blue Barn" in 1974, which was completed in 1977. By the early '90's a resurgence of new volunteers saved the fair from extinction. Livestock entries rebounded from a low of 29 exhibitors in 1988 into hundreds in the mid-'90's. Much is still yet to be done to bring back participation in the Consumer Sciences area.

In the last 10 years the fair has seen many changes, some due to lack of volunteers, some due to the economy and some due to the participation of exhibitors. Many changes were introduced and were successful, some had to be adjusted and some just didn't work. The Fair is a continually growing animal itself and success is gained through trial and error.

For over 70 years the fair has strived to meet the needs of our kids and our community. This could only be made possible by the support of the entire community who are whole-heartedly interested in our youth.

The original intent of the fair is still the primary motivation for all the hard-working volunteers that make each and every fair a unique experience!

A special THANK YOU to the Fair Board Officers, Directors, Superintendents, Members and families, along with the countless volunteers for their hard work to make this year's fair a success!!






RULES AND REGULATIONS

ENTRIES

- Entries in all Livestock Departments must be completed **online** by midnight on June 1st for small and large animals, **NO EXCEPTIONS!** Entry dates for the Horse & Dog shows differ, see the entry form in the Premium book for these dates.
- All entries are accepted with the understanding that neither the West Valley Fair organization, sponsors, nor their officials, shall be held responsible for any damage or loss that may arise to livestock on exhibition or for sale.
- No refunds will be given without written request to the West Valley Fair Board within 30 days of the Fair sale date. Refunds will be at the discretion of the Fair Board.
- Entries are open to all regularly enrolled 4-H and FFA members in good standing.
- Cloverbud 4-H members may enter the fair as participants only, according to the guidelines and policies as stated in the 4-H Handbook.
- Due to limited space, entries will be limited to exhibitors residing in Yakima County north of Union Gap, EXCEPT for Horses, Dogs, Cats, Critter Pals (Rats, Cavies, etc), open entries in Blue Barn, and Fleece & Fiber entries.
- Entry fees are as follows:

Market Beef, Sheep, Swine and Goats:	\$13.00 each
Breeding Beef, Dairy, Llamas, Sheep, Swine, and all Goats:	\$13.00 each
Dogs:	\$8.00 each (additional \$1.00)
Rabbits and Poultry:	\$8.00 each
Cats, Critter Pals and Cavy:	\$8.00 total
Horse:	\$35.00 each (additional \$10.00)
- Exhibitors are allowed two (2) market animals.
- Non-market entries will be accepted up to the limit of facilities available. In case limits must be imposed, entries will be allowed on a pro-rated basis to each exhibitor.
- Exhibitors shall not enter the same division in both 4-H and FFA. Neither shall 4-H or FFA members compete against each other.
- Indicate age **as of October 1st of the previous year** in the box on entry form for showmanship division. Age divisions are as follows: Cloverbuds: 5 to 7; Juniors: 8 to 10; Intermediate: 11 to 13; Senior: 14 to less than 19. FFA members can show after their Freshman year through the year immediately following graduation.

EXHIBITS

- Animals must be under the care and management of the exhibitor for the following time prior to the fair:

Market Beef	120 days
Horse, Dairy, Beef Heifers, Llamas	90 days
Sheep, Swine (Market & Breeding)	60 days
Goats, Cats, and Dogs	60 days
Rabbits, Poultry, Cavy, Critter Pals (rats, etc)	45 days
- No animal previously shown in a market class and sold may be shown at West Valley Fair in a market class.

- **All qualified market animals entered for competition must be sold in the auction ring. Each exhibitor must lead or drive his own livestock through the sales ring unless specifically excused by the West Valley Fair Board.**
- Weighing of market animals will be done ONE TIME ONLY, right off the truck!!! At the discretion of the Superintendent, any **animal needing to be cleaned will be weighed after they have been washed**. See "Program of Events" for time and order. Scale weight will determine sale weight, except Steers will receive a 3% shrink.
Scales will be closed from 6:00AM Monday until 2:00PM Wednesday, the week of the fair for scale certification.
- **Only two market animals may be weighed off the truck, however, exhibitors may bring one spare market animal of each species to be weighed if needed. All animals and completed paperwork must be present at time of weigh-in. There will be no returning with the spare animal.**
- Weight limits: Steers must weigh at least 1,100 pounds; Market lambs 100-150 pounds; Market Goats 75+ pounds; and Market swine 240-300 pounds.
THERE WILL BE NO FEEDER OR HEAVYWEIGHT CLASSES (At the discretion of the Fair Board, depending on entries and space, animals may be reclassified). Animals not making weight will be sent home. Scales are certified the week of Fair, all weights are final, no re-weighing.
- No stags or unaltered animals will be shown in market classes. All market lambs must be slick shorn prior to the fair or they will be ineligible. Any crimping must be done at least 60 days prior to the fair or they will be disqualified. **Market Goats must be polled or dehorned and have no scurs.**
- All entries must be fitted and shown by the enrolled 4-H or FFA member only. Infraction of this rule shall be cause for dismissal from the show. Animals may be sold by another member only with Fair Board pre-approval.

AT THE FAIR

- **ABSOLUTELY no dogs are allowed on premises!!**
- **All exhibitors attending the show must be responsible to a high school agriculture teacher or a 4-H leader for the duration of the fair.**
- Any exhibitor or contestant found guilty of using or having in their possession any intoxicating liquor or drugs (including tobacco products, if under 18) will be barred from the fairgrounds and from participating in any activities.
- **Any 4-H or FFA member taking part in the fair found guilty of misconduct, such as destruction of property, boisterous conduct, profane language, or disrespect to any adult in authority, may have his/her stock withdrawn from the fair and be sent home. Abuse of this rule may disqualify either individuals or teams from any awards which they may receive.**
- No exhibitors, spectators, or parents will be allowed in the barn area between 10:00PM and 5:00AM without special permission.
- No camping will be allowed in the barns. No camping will be allowed on the grounds by exhibitors unless supervised by an adult. Gates are locked as indicated on the daily schedule. Camping is at your own risk. West Valley Fair does not accept any liability for damage while your RV is on the grounds.
- Due to safety concerns, animals designated by the Superintendent as improperly trained for the show will become ineligible for the show and sale and must be removed from the fairgrounds.
- The Livestock Superintendents and their assistants reserve the right to reject any entry on the basis

of health, sign of disease, or abuse of animals. Visual inspection will be made by a veterinarian.

- Animals entered in the wrong class may be reclassified by the Superintendent, but exhibitors are not allowed to withdraw or change their entries after the opening of the fair.
- **Decisions of the judges will be final.** Any animal or article not deserving of an award will not be given the award. Should any animal or article be awarded a prize be disqualified, the exhibit gaining the lower prize shall be moved up one position if the judge sees them fit for the award.
- All protests must be made in writing and presented to the fair organization within 12 hours of the incident. The protest will be acted on within 12 hours of receipt of the protest. The Fair Board's decision in regard to the judging decisions, rules interpretations, and management rulings shall be final in all cases.
- An appropriate dress code will be adhered to throughout the show. Acceptable attire must be worn into the show ring. 4-H: clean clothes, no open-toed shoes, no tank tops, sleeveless shirts, low cut shirts, or shorts. FFA: official dress pants, white shirt, tie or scarf, FFA jacket and appropriate shoes.
- All Record Books for Livestock and 4-H Family and Consumer Sciences must be up-to-date and turned into the Blue Barn by 8:00PM on Wednesday evening. Failing to turn in your Record Book will disqualify you from showing. Stall cards will be issued when a completed Record Book is turned in for judging.
- A stall card must be filled out and displayed for each animal.
- Every 4H Club or FFA Chapter must be identified with a banner or sign.
- A "Code of Ethics" must be included in every exhibitor's Record Book. It must be signed by the exhibitor, parent or guardian, and the Project leader.
- The Fair will furnish the 1st bedding for livestock, Exhibitors are responsible for their own bedding thereafter. Exhibitors are responsible for placing and keeping fresh bedding in their stalls.
- All livestock entries must be secured in their assigned stall by 8:00PM on Wednesday with all required safety chains in place.
- All livestock entries must be available for the judging contest if selected. There will be no exceptions.
- Exhibitors who are in their final qualified year of participation, may elect to present a "farewell" letter to be read at the time they sale their animal.
- Market animals will be listed on the sale sheet and sold in the order of placing by the judge in the Market classes. 4-H will start the sale in even years and FFA in the odd years.
- To help defray the expenses of the show, no less than 2% and no more than 4% will automatically be deducted from the total amount of the sale of all market animals sold. This includes all add-ons.
- Animals may **NOT** be purchased from the turn pen after the sale. Any animal not meeting market sale requirements may be sold by private treaty without any West Valley Fair involvement or responsibility.
- All "add-ons", or money added to the exhibitor's market sale price, must be paid on the day of the sale. Add-on's will not be accepted for any animal that does not make weight.
- All exhibitors must remain on the grounds until stalls and show areas are all cleaned.
No cleaning pens or removing decorations until AFTER the livestock sale on Saturday. Removing earlier will result in forfeiting all awards and a charge of \$50 will be billed.
- Stalls must be cleaned to the satisfaction of the fair officials or a cleaning charge of \$50 shall be charged to the person responsible.

- Checks will be mailed to each individual exhibitor from the sale of livestock as soon after the show as is financially possible. It is the responsibility of the exhibitor to notify the Fair Board if their mailing address differs than the one on their entry form.
- It is **mandatory** that all exhibitors work at least one (1) scheduled workday before the fair. If you cannot make a workday you will be REQUIRED to work three (3) hours during the fair. Exhibitors will be respectful to the supervisors assigning work and complete the duty assigned.

HEALTH REQUIREMENTS

- Washington livestock require no vaccination or test for entry.
- All sheep and market goats are required to be identified with a Scrapies tag or tattoo. Scrapie tags or tattoos **must** be in place prior to check in.
- Swine are to have an erysipelas vaccination and a booster 21 days later or by label instructions.
- Fair veterinarian will inspect all divisions before they are exhibited to determine that the exhibit is free from any infectious or contagious diseases and exoparasites.
- Fair veterinarian must and will reject any animal with infectious or contagious diseases or exoparasites. Exhibitors should be aware that ringworm, warts, pinkeye, strangles, contagious exthyme, lice, ticks, and fleas all fall into these categories.
- No animal from any quarantine area will be allowed to show in any fair.
- All out-of-state entries must comply with the State of Washington Import Regulations.
- **Health certificates are required at weigh-in for ALL market animals entered.**

LIVESTOCK SALE

SALE ORDER: Beef, Swine, Sheep and Goat

All bidders / buyers must register at the Sales Table on the day of the sale and receive a bidder number.

Buyers are responsible for making arrangements for all “custom” animals. The West Valley Fair is not responsible for “custom” animals after the livestock sale concludes and will not house them after the sale.

Buyers are encouraged to pay for all purchases and add-on's at the conclusion of the livestock sale at the Sales Table. Statements will otherwise be mailed to the purchaser within one week of the sale and are required to be paid for within 30 days.

All floored animals **MUST** be paid for before leaving the Fairgrounds.

NO EXCEPTIONS!!

HOW TO BID / BUY AN ANIMAL

- All bids are by the pound, weight is net. (Steers will receive a 3% shrink.)

OPTION 1: Example: If you bid \$1.00 a pound on a 120-pound lamb and the floor price is 50 cents, you can "turn" the lamb to the packer and pay \$60.

OPTION 2: Example: If you prefer to keep the animal for your own personal use, you would then pay the total bid price of \$120.

DERICK PARTLOW MEMORIAL

Derick Partlow, forever 9, was an outstanding member of the Naches Valley 4-H Club. Derick showed sheep, pigs, goats, and his llama. He loved the West Valley Fair, showing, competing and playing with his 4-H friends.

In loving memory of Derick, a traveling trophy and a belt buckle will be presented to the outstanding exhibitor of the fair. This award will be presented to the exhibitor who shows outstanding sportsmanship, is helpful to other exhibitors, works on and cleans up the fairgrounds and is an overall exceptional exhibitor who makes the West Valley Fair an outstanding fair.

There will be a ballot box where exhibitors may nominate boys and girls who they feel meet these criteria. The top three nominated exhibitors will then be voted on by the Partlow family to choose the outstanding exhibitor of the fair.

This trophy will **not** become the permanent property of any exhibitor.

A cash award of \$100 will also be presented to the Derick Partlow memorial recipient, on behalf of Kyle Dexter and family.

RECORD BOOK



***** All 4-H and FFA livestock exhibitors are required to keep an accurate set of records and are required to submit a Record Book.***

All 4-H and FFA Record Books must be turned into the Blue Barn for judging no later than 8:00PM on Wednesday. They need to be in a notebook or binder with all pages and pictures securely fastened. Books will be scored on completeness and must include all projects being exhibited. Books will be returned after the livestock sale on Saturday.

Books must include a cover, calendar, code of ethics (see page 18), project record for each project (which includes the plans, journal, summary, pictures, costs, health records), a permanent record, story, and a supplemental page.

Juniors and up must use Level II Record Books.

Rosettes will be awarded to 1st, 2nd and 3rd place books.

CODE OF ETHICS

All Exhibitors MUST include a copy of the Code of Ethics in their completed Record Book. Completed signatures on the Code of Ethics certify that the Exhibitor is eligible to participate fully in the youth Animal Science Program in Yakima County.

- ⇒ I believe that participation in the Washington Youth Animal Science Program should demonstrate my own knowledge, ability, and skill as a feeder and exhibitor of animal projects.
- ⇒ I will do my own work to the full extent I am capable and otherwise will only accept advice and support from others.

 - * the proper care and safe humane treatment of my animals.
 - * the production of a high quality, safe and wholesome food if my project is market,
 - * demonstrating strong moral character as an example to others.
- ⇒ I consent to having my animal(s) subjected to drug testing.
- ⇒ I understand that no one is allowed to coach a contestant while said contestant is exhibiting in the Show Arena.

- ⇒ Contest is contingent on the availability of a superintendent.
- ⇒ Contest is contingent upon there being more than three applicants.
- ⇒ If only four applications are received, Superintendent has the option to keep all four. If five or more applications are received, the top three candidates will represent the Fair.
- ⇒ Royalty Superintendent must be notified of intent to compete prior to May 15th. At which time you will receive rules and regulations along with an application which will need to be completed and signed by the applicant and parent/guardian agreeing to rules and regulations set forth by the West Valley Fair Board.
- ⇒ Record book and application are due by May 30th.
- ⇒ Contestant must 8th grade or older as of January 1st of the current year.
- ⇒ Contestant must be enrolled as an active 4-H and/or FFA member.
- ⇒ Contestant must be a current West Valley Fair exhibitor.
- ⇒ Royalty must wear the provided shirt while on the Fairgrounds, with the exception of any time they are involved in competition or cleaning of animals / pens.
- ⇒ Royalty members will be chosen by a combination of points from the completed application, record book, and personal interviews.
- ⇒ The Fair Board will provide each member of Royalty 2 shirts, 1 crown and 1 sash.

The majority of the fair publicity falls on the candidates (posters, news releases, interviews, etc.). Contestants must be available for reasonable appearances and responsibilities during the four weeks of the contest and for parades and other functions throughout the year as set forth by the West Valley Fair Board.

- Contest will be held at 8:00AM Thursday.
- Contestants will be able to walk around the stock.
- Concurrent contests will be held for 4-H, FFA, and Adults.
- Perpetual Awards will be given to the highest scoring individual in 4-H Junior, 4-H Intermediate, 4-H Senior, FFA and adult, along with a keepsake banner.

4-H Members:

1. All regularly enrolled 4-H members will be divided into three divisions: Juniors, Intermediates, and Seniors.
2. One set of oral reasons will be required of 4-H Seniors and Intermediates. This set of reasons will be taken from one of the 8 classes of livestock judged. The selected class will be on the species that sells first and appropriate cards will be distributed. Orals will be done right after the livestock judging portion of the contest. The judge will not give reasons for the class chosen. The reason portion of the contest is not required for Juniors; they may participate but will not be scored. A 1st place award will be given to winners in the Junior, Intermediate and Senior classes.

FFA Members:

1. Only regularly enrolled FFA members may judge.
2. Five members will constitute a team; the top three scores will make up the final score.

Adults:

1. Any adult is eligible.

3. Should have a single dominant theme.
4. Should educate quickly.
5. Should be creative and original.
6. Should be clean and neat.
7. Information should be specific rather than general, pertinent and of interest, clear and concise, and readable from a distance of 10 feet.

A total of 50 points are available.

Awards will be given to the top three clubs/chapters in each division (per species, large and small club). A club chapter must have an average score of 80 or more to be eligible for an award.

HERDSMANSHIP

Superintendent: Marcie O'Neal

The Herdsmanship Contest begins Wednesday evening and continues until Friday evening. A separate contest will be held for 4-H and FFA. A separate contest will be held for clubs with five (5) animals or less and clubs with six (6) animals or more.

The contest is held to encourage exhibitors to:

- Care for their own projects, equipment, pens, and surrounding areas.
- Display their projects in a showmanship manner.
- Keep their animals and stalls clean at all times.

A judging committee will inspect pens, surrounding areas, and animals daily during the fair. A total of 100 points are available per judging occurrence. A total of 80% of the total points possible are needed to qualify for any award.

Awards will be given to the top three clubs/chapters in each division (per species, large and small club). A club chapter must have an average score of 80 or more to be eligible for an award.

NOTE: All aisle ways in all barns are to be kept clean at all times!



Example 2: If you show breeding beef in FFA and market beef in 4-H, you will compete in BOTH FFA and 4-H beef contests with the animal entered in that Division. You must fit both animals.

Example 3: If you show both breeding stock and market, in the same youth organization, i.e. 4-H or FFA, you need only show once.

1. FFA starts Fitting and Showing, followed by 4H Seniors, Intermediates and then Juniors.
2. Entries are open to any regularly enrolled 4-H or FFA member who is exhibiting at this fair.
Entrance in this contest will not bar exhibitor from any other contests in which they are eligible.
3. Requirements: each contestant must own the animal they show. Each contestant must fit their own animal and may only be assisted by other regularly enrolled 4H and FFA members entered at the fair. **NO ADULTS.**
4. Exhibitors must show that same animal in all phases of showmanship.
5. Ratings will be as follows: 50% Fitting and 50% Showing.



BUCKET OF JUNK CONTEST

The objective of a "Bucket of Junk" is to create a sculpture using only the items in the bucket. A sculpture is defined as a three-dimensional work of art that can be viewed from 365 degrees.

Five-gallon buckets of junk will be given to 20 entries on a first-come, first-serve basis. All 20 buckets will include the same number of items of unique pieces, otherwise known as junk. Participants may clean, sand, weld, glue, cut, bolt, fasten bend, shape, paint or finish the items that are provided. No pieces may be added, and only one item can be left out of those provided. The object is to use all the pieces to create a work of art. There will be a list of contents in each bucket; return it when you submit your sculpture. All sculptures must be presentation-ready when submitted. Projects may be mounted to a solid base for stability if needed.

Buckets can be picked up at the May 3rd Work Day at the Fairgrounds, arrangements can also be made to pick up at a later date by contacting Kattie Blanchard.

JUDGING CRITERIA:

- Contestant used only the materials that were provided (required).
- 25% Contestant used the materials in a new way to create something different.
- 25% Contestant's ideas are recognizable. (Clarity of the idea.)
- 25% Contestant's overall finished appearance of the sculpture.
- 25% Difficulty of the piece and how well it was made.

YAKIMA COUNTY 4-H QUILT BLOCK CHALLENGE

- ADGA Dairy Goat Showmanship Score Card (CO544) will be the guide for Showmanship.
- All dairy does in milk must be milked completely after 6:00PM of the night before the does are to be exhibited. The Superintendent of the Goat Show has sole authority and responsibility to certify that each animal has been milked.
- **No horned dairy goat will be allowed. It is your responsibility to know what category your goats fall under.**
- **All horned Boer meat goats must have horns appropriately covered for safety precautions. Horn coverings must be secure, please test coverings before fair time.**
- BUCKS under 4 months of age may be shown in a breeding class.
- Exhibitors are limited to 6 goats. (This includes market animals and all kids).
- Exhibitors may enter only two (2) entry per breeding class.
- Exhibitors must pay entry fee for all animals brought in, this includes kids that are still on does and are not being shown in a class.
- **It is mandatory that all goat exhibitors wear appropriate clothing for ALL their classes.**

Showmanship exhibitors must wear the following:

Dairy exhibitors – white pants / white shirt with collar and closed-toed shoes.






